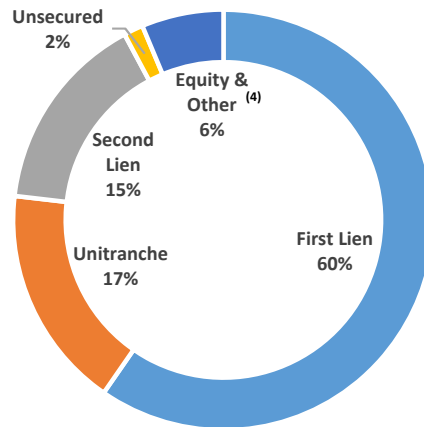

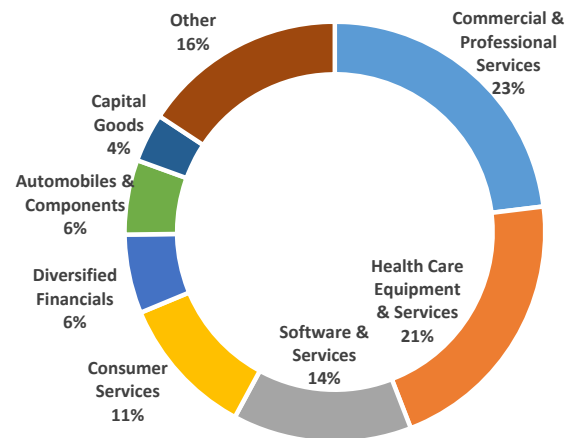

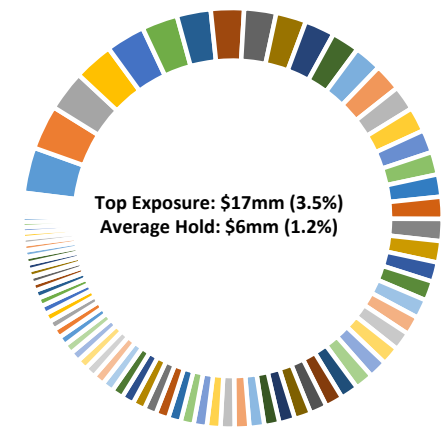
Asset Type

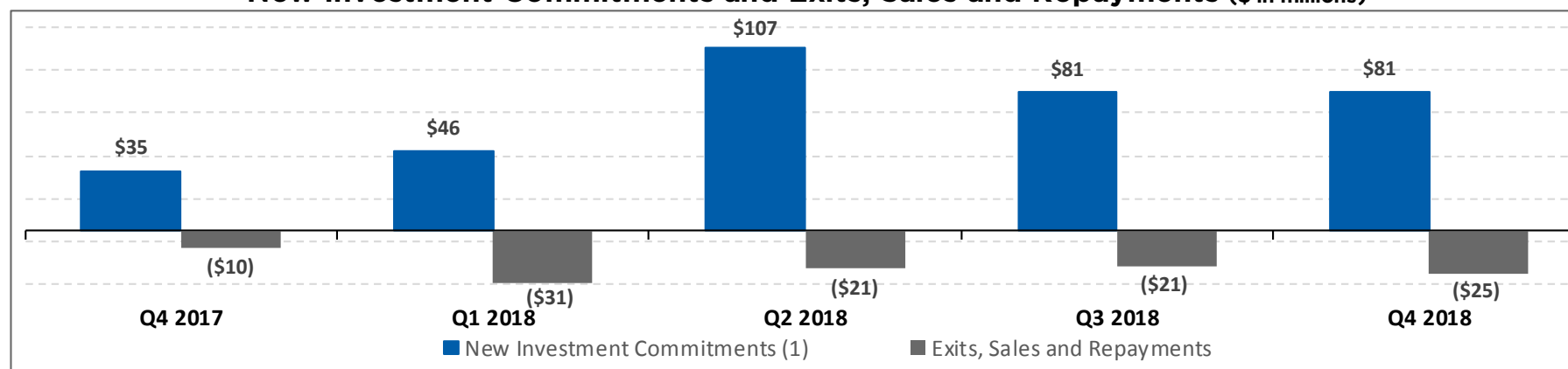

New Investment Commitments and Exits, Sales and Repayments (\$ in millions)



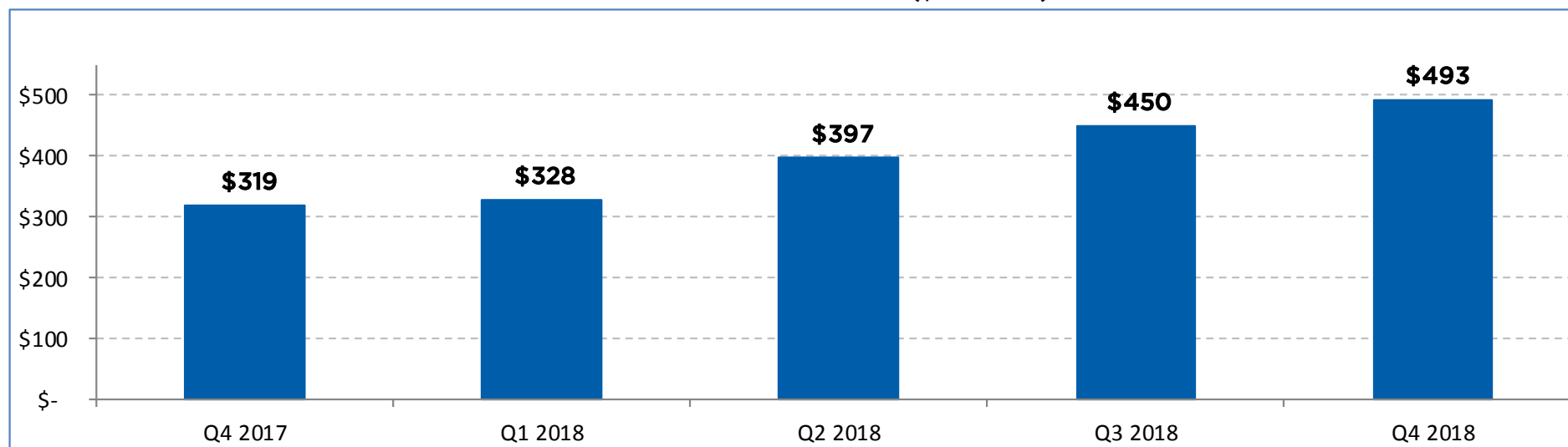

Growth in Investments (\$ in millions)

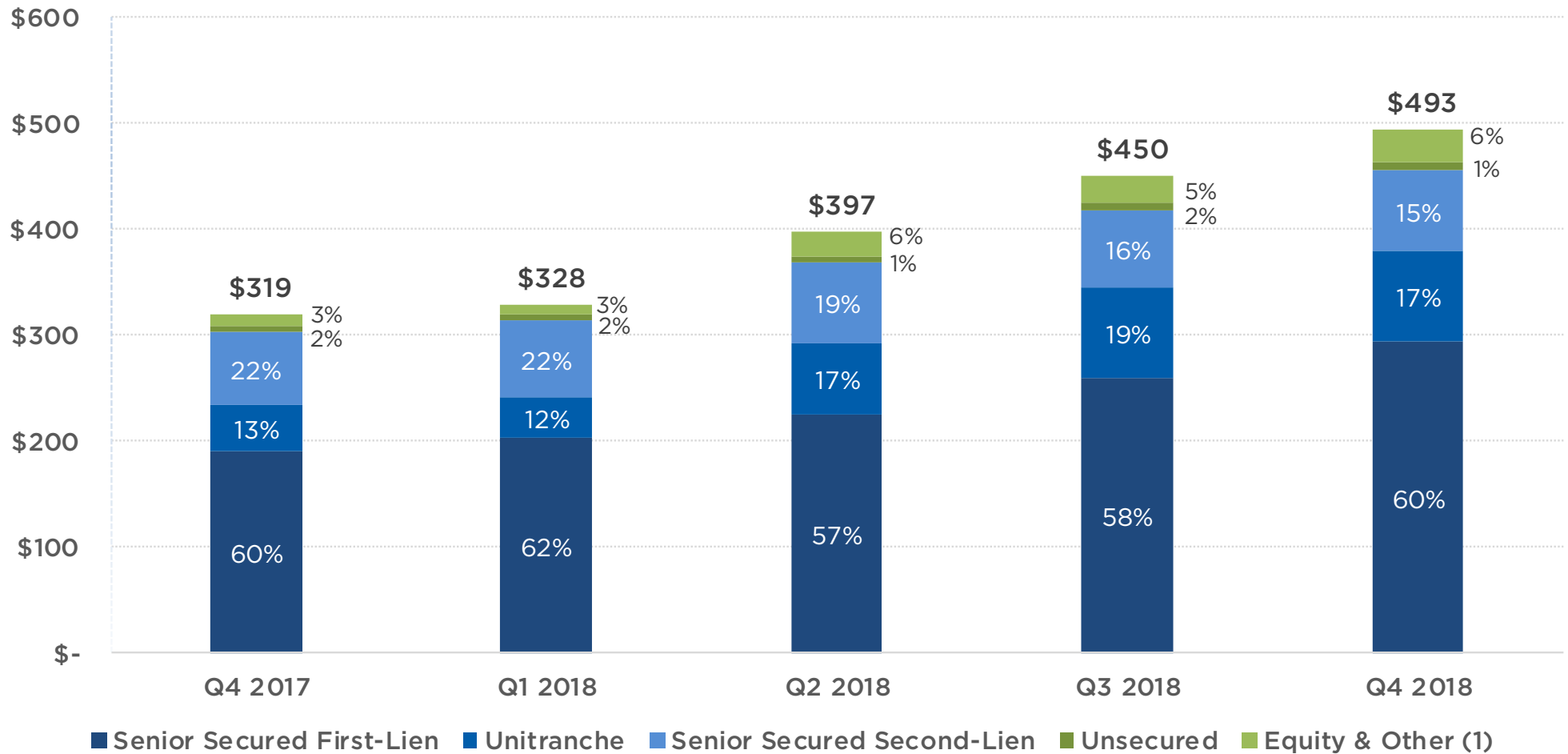

B. Financial Results

Summary of Quarterly Results – December 31, 2018

- Net investment income for the three month period ended December 31, 2018 was \$6.0 million, or \$0.47 per share, which compares to \$4.9 million, or \$0.43 per share for Q3 2018
- Declared Q4 2018 dividend of \$5.3 million, or \$0.40 per share, which compares to \$4.5 million, or \$0.38 per share for Q3 2018. Dividend coverage for Q4 2018 was 112%⁽¹⁾
- Net decrease in net assets resulting from operations for the three month period ended December 31, 2018 was \$1.8 million, or \$0.14 per share
- Net realized and unrealized loss on investments of \$7.7 million, or \$0.61 per share
- Net asset value per share was \$19.43 as of December 31, 2018, down from \$19.97 per share as of September 30, 2018

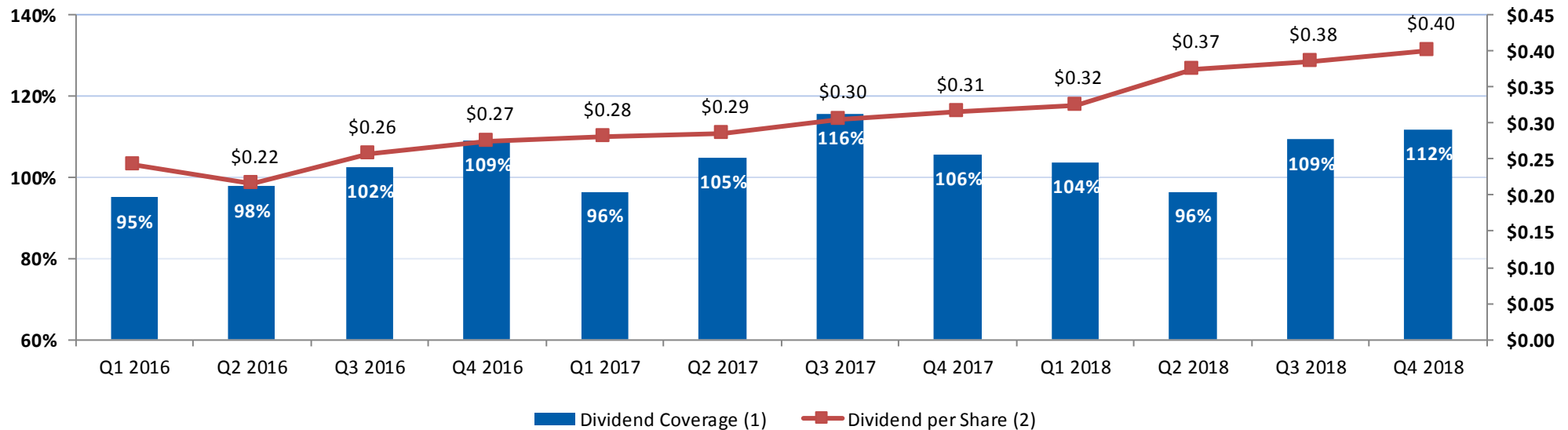

Consistent and growing dividend per share

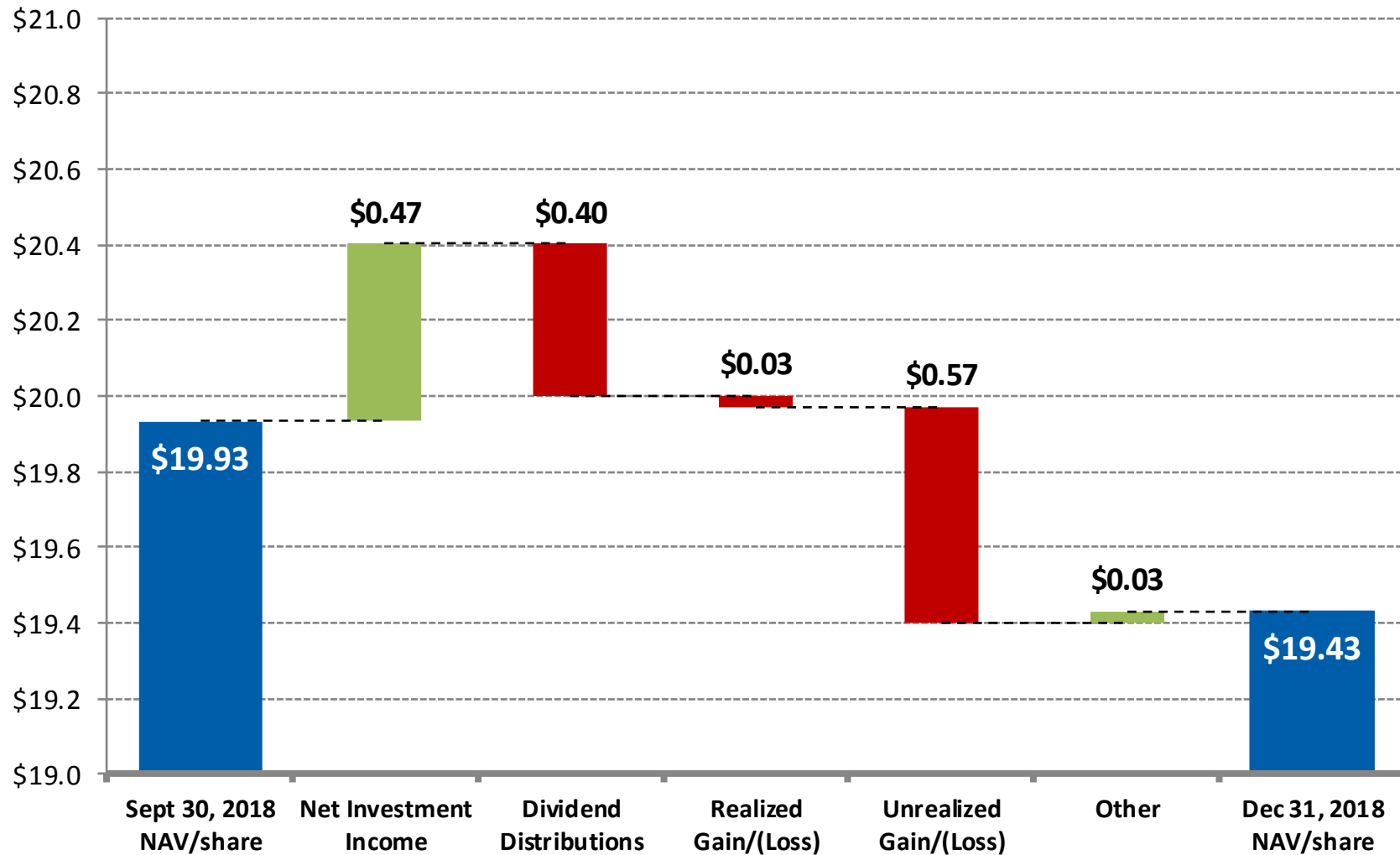
Annual Net Investment Income expected to cover 100% of the annual dividends (i.e. no return of capital)

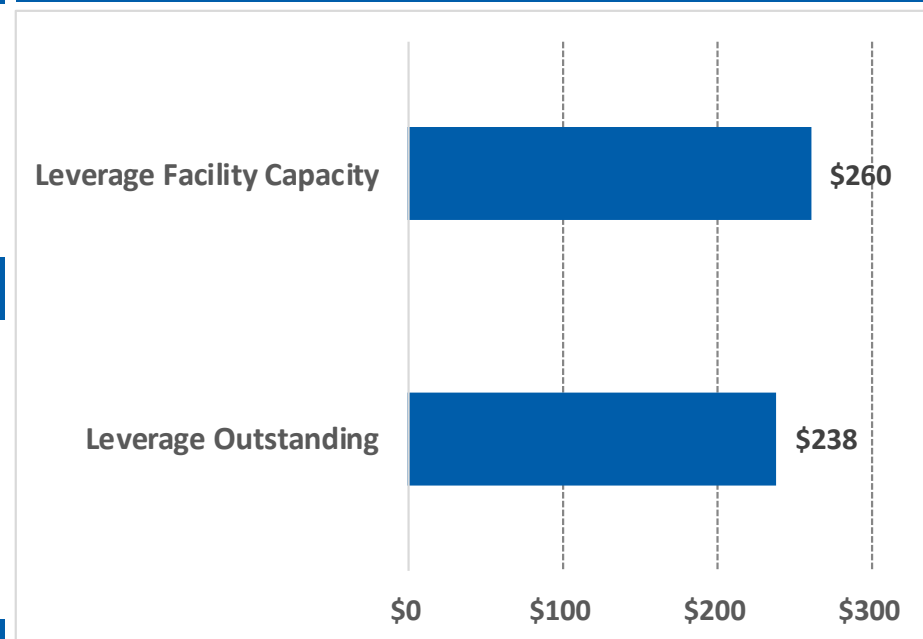
